## Licencing

The ever-evolving world of security means Standards of quality and professionalism are more important than ever. Many of these Standards are governed by industry stakeholders, such as the Security Industry Authority.

The SIA is the government body responsible for managing the licensing process. To qualify for a licence, you need to be over 18, pass an identity and criminality check, and show that your skills and knowledge meet nationally recognised Standards.



# Why types of licences are there?

There are five types of licence:

Cash and valuables in transit: for guarding property against damage or theft and transporting it in a vehicle designed for secure transportation.

**Close protection:** for guarding people against physical assault or injury.

**Door supervision:** for guarding licensed premises against damage, theft, unauthorised access, or disorderly behaviour.

**Public space surveillance licence:** For guarding premises, property, or people by using CCTV to:

- a. Watch members of the public or identify particular people.
- b. Guard against disorder or protect people from assault (this includes using CCTV to stop incidences occurring, or provide information about them if they do happen).

**Security officer:** For guarding premises or property against damage, theft, unauthorised access or disorderly behaviour.
