## What to look for in a reputable shredding and recycling contractor

#### **British Shredding Standard EN15713:2009**

British Security Industry Association (BSIA) Information Destruction companies comply with European Standard EN15713:2009. The standard means that you can have complete confidence in your contractor and is an excellent benchmark for customer service. The standard will be incorporated in members' ISO 9001:2008 quality system which is inspected by a UKAS accredited certification body, guaranteeing secure service. #### **Data Protection Act 1998**

An approved contractor must be well versed in the Data Protection Act (DPA) 1998, and understand that under 'Principle 7' a written contract must be in place between the Data Controller (customer) and Data Processor (shredding contractor). Also, the contractor should be registered under the DPA.

# Personal and corporate identity theft

Your identity is a valuable commodity — you need it to function in everyday life.
