What to look for in a reputable shredding and recycling contractor?

European Shredding Standard BS EN 15713

The standard is incorporated in members' ISO 9001 quality system which is inspected by a UKAS accredited certification body, guaranteeing secure service.

Data Protection Act 2018

An approved contractor must be well versed in the Data Protection Act (DPA) 2018, and understand that under the Act – Article 59(5), a written contract must be in place between the Data Controller (customer) and Data Processor (shredding contractor).

The UK General Data Protection Regulation (UK GDPR), tailored by the Data Protection Act 2018 applies to most UK businesses and organisations. It explains each of the data protection principles, rights, and obligations and summarises the key points you need to know, answers frequently asked questions and contains practical checklists to help you comply. Personal and corporate identity theft
