





Cybersecurity: Protecting our members and their customers from the increasing risk of cyber-crime is the core focus of the British Security Industry Association's wide-ranging cyber security activity, and we host an online portal to allow members access to the latest advice and guidance to help them and their customers reduce the risk they face. Members also benefit from a reduced price on vital cybersecurity training and **Cyber Essentials** certification.

Guidance on industry issues: Giving its members a competitive edge is central to the guidance and education provided by the BSIA. The Association regularly provides in-depth guidance and advice to members on a number of key issues facing the industry. In a recent survey, members reported the highest levels of satisfaction with the BSIA's provision of guidance on industry issues.

Export support: Whether your company has long-established links overseas or you are considering making the first steps towards exporting, the BSIA has a wealth of experience and expertise in this area to assist you. We can provide contacts for overseas commercial officers and supply market information. We also organise successful UK pavilions at key security industry exhibitions worldwide, bringing real commercial benefit together with our investment in the UK's largest international trade exhibition, **IFSEC International**.



Parking charge notices: Since 2008, the BSIA's dedicated parking charge notice (PCN) appeals team has been working on behalf of members to appeal parking tickets issued to cash-in-transit vehicles parked outside delivery points across the UK. Constant contact with local authorities has resulted in the team winning more than 70,000 appeals, saving member companies over £1.9 million.

SaferCash

Specialist benefits



SaferCash is a security initiative, which aims to reduce the number of attacks on cash-in-transit couriers through the effective sharing of intelligence between the cash in transit industry and Police forces nationwide.

Establishing a partnership between industry and police has given SaferCash the ability to identify linked offences and spot where organised crime groups (OCGs) are active across force boundaries. In the case of cash and valuables in transit, organised criminal gangs are increasingly operating on a nationwide basis, impacting on local communities and funding other criminal enterprises.

SaferGems

SaferGems is a major initiative against crime in the jewellery, antiques and fine art trades.

The SaferGems team, which has links to all the UK police forces coordinates data from the trade on incidents and suspicious events, sends alerts to members of the National Association of Jewellers and those insured via T H March.


It also coordinates data across police forces to improve identification and conviction of criminals.



